RE: January 31, 2016 Budget Monitoring Report

A few noteworthy financial highlights follow:

**Total Operating Revenue** exceeded budget year to date expectations by \$78,667 or 23.2% after the 1<sup>st</sup> month of the new fiscal year. Similar to the start of last year, one of the Telecommunication Companies (i.e. AT&T) leasing space from the City for wireless communications paid late. The amount of \$34,386 was scheduled to be received in 2015 rather than January, 2016. A double the amount late payment penalty was received from the company on February 3, 2016.

<u>Utility Taxes / Franchise Fees / Business Licensing Revenues</u> are \$6,142 or 4.3% above budget for money received through January 31, 2016. A more up to date view of this revenue source is added in **blue** with cash receipts included from early February, 2016. Please see the table below for details:
