- The applicant shall obtain and maintain in full force and effect during the full period of the permit, public liability insurance, as described in Clyde Hill Municipal Code Section 12.14.070(B). Proof of such public liability insurance policy shall be provided to the City Administrator before the issuance of any permit.
- If required, the applicant shall obtain a surety bond, as set forth in Clyde Hill Municipal Code Section 12.14.070(A). Proof of such surety bond shall be provided before issuance of any permit.
- Declaration of Agency form.

It shall be the responsibility of the applicant to restore any and all landscaping disturbed or destroyed in the right-of-way to the condition existing prior to the disturbance as approved by the City.
