Work in Right-of-Way / Street Opening Application and Permit

Conditions of Permit:

1. Notify the city of job starts 24 hours in advance of the work, either call 425-453-7800 or email cityhall@clydehill.org.
2. This permit shall be valid for 180 days.
3. All work within the street or right-of-way areas must be done in accordance with the specification of the City, as contained in Title 12 of the Clyde Hill Municipal Code. A copy of Title 12 may be obtained from the City Clerk.
4. Traffic control and work area warning devices must conform to the requirements of the Manual on Uniform Traffic Control Devices, Part VI, Standards and Guides for Traffic Control for Street and Highway Construction, Maintenance, Utility, and Incident Management Operations, as published by the U. S. Department of Transportation, Federal Highway Administration.
5. Mixing of concrete or mortar on sidewalks or streets is strictly prohibited.
6. All trench backfilling and street restoration shall be accomplished subject to inspection and approval of the Director of Public Works or his/her representative. The applicant and/or contractor shall restore the street or right-of-way surface to the condition, which will allow vehicles or persons to travel thereon safely, but at least to as good of condition as was existing at the time the applicant, and/or contractor commenced work. Such restoration shall be made within a reasonable length of time and shall be performed to the satisfaction of the City of Clyde Hill.
7. This permit does not constitute permission to connect utilities.
8. All excavated material to be removed shall be disposed of by the owner and/or contractor. All backfill shall be approved by the City and shall be per the City's Standard Specifications defined in Title 12.
9. Rights acquired under this permit are inferior to those acquired under existing or future street improvement contracts.
10. This permit is wholly temporary in nature and vests no permanent rights whatsoever and is revocable under the applicable City ordinances.
11. Work Hours: Monday-Friday: 7am to 6pm, Weekends and Holidays: 10am to 4pm
